

# 6A - CIVL President Report

The number of events and average number of pilots are up versus 2022. Revenue is up from 2022, exceeding pre-pandemic levels.

Cross-country Paragliding accounts for the majority of both the number of events and the revenue. It accounted for 67% of all CIVL income in 2023. Events became more expensive in 2023, with 44% of events charging over 300 euros for an entry fee compared to 32% in 2019.

#### 8 – Report of the CIVL Treasurer

The provisional end of year 2023 CIVL accounts, (Refer Annex A) indicates that there has been a significant increase in income compared to previous years as well exceeding the planned 2023 budget by over 23%. The projection was 91.6k CHF, but in practice we achieved 113.4k CHF.

From an ASC Financial Secretary's point of view, the lack of meeting the forecast is disappointing. There are mixed sentiments regarding the expenditure results compared to the budget predicted figures. Firstly, the financial benefit is that we did not incur the expected deficit, reducing the overall expenditure costs by over 40%. Outgoings were only 79.6k CHF instead of the projected 142.3k CHF: a shortfall of some 62.7k CHF

#### 2024:

The provisional budget for the 2024 CIVL accounts, as accepted by the FAI, (Refer Annex B), shows that the Bureau again intends to have a planned deficit using the CIVL reserves to develop and maintain the sport. Looking at the current trend of events, the CIVL income is projected to be approximately 153.1k CHF, with an expenditure of 157.4k CHF. based on these figures the deficit should be a reasonable 4.3k CHF. This predicted, relatively low deficit will be achieved by the better return of sanction fees as approved at last year's Plenary.

### 2025

CIVL is required to approve a CIVL budget for 2025 during 2024. which will be forwarded to the FAI for inclusion into the 'roll-up' of their overall Federation budget. The first draft is to be compiled, approved by the Bureau, and forwarded in May 2024 to the FAI. This will include input from the competition bids approved at the Plenary. Currently, it is envisaged that the final 2025 budget will be similar to 2024 figures.



#### 25B — Proposals Bureau — adjust team size for fairness PGXC Worlds

The 2006 plenary adopted rules for PG XC World Championships that are based on the "Olympic Spirit" where, as far as possible, nations are given an equal chance at be on the team podium. Currently, we have strayed from that philosophy and paragliding world championships again have team sizes that vary considerably among nations. Even though the number of scoring pilots is fixed, some nations are able to bring additional pilots and these pilots can assist their "team" pilots. This gives these nations a considerable advantage over nations who are not able to field extra pilots.

#### Proposal

- Team size would be fixed at n+1, where no more than n pilots may be of the same gender.
- Each day, the 2 highest scores would be added to get the team's score for that task.
- Nations would not be allocated extra slots for "non team" pilots. The maximum number of pilots a team could bring would be n+1.
- Teams may be smaller than n+1, with the same scoring rules as above being used.
- "n" will be set at least one year in advance, and for the World Championship in 2025 is proposed to be "3".

# 38E - Proposal Poland - Communication and Safety

Problem: Blocked radio and cloud flying.

Proposal:

It is often difficult to set an upper altitude limit, since the cloudbase can differ with time and place. Therefore it is not announced in a briefing, but a specific time is set - a 20 minutes before opening the window for example - when it will be announced on safety frequency. Then a couple of designated marshalls get flying in launch area in order to assess the viable altitude and advise the meet director. When the decision is taken on the altitude limit, it gets transmitted and any pilots who happen to be above must get below before the task starts — there is enough time to do that safely. In this way we have both problems solved: everybody knows the limit, and all pilots who did not hear anything at given time go check their radios, as it means they have been transmitting.

# 38K – Proposal France – PG Worlds

Worlds are not fair. Some nations have many pilots which gives an advantage to the team. On the other hand it would not be fair if the best country has to leave 20 pilots at home, while a bad nation can send 3 pilots that have no chance to win.

CAT.1 Worlds championships in PG XC are organized separately for Team and Individual titles, alternatively every second year starting in 2025.

# 38L – Proposal Argentina – Cap Pr

Having a Pn of more than 109 pilots make no sense. Competitions with less pilots but still very high level get devaluated, while others get filled up with bad pilots that are only dangerous to the others. Therefore Pn should be lowered.

### 38N — Proposal UK — Reduce Rank&Points for FAI PG XC

This proposal is to reduce the entry requirements to participate in Paragliding XC for FAI 1 events (European and Worlds). The current restrictions are very punitive to women's participation and thus also impact a nations Team representation.

### PROPOSAL:

- We propose to increase from 700 to 1,000 in the FAI ranking to be eligible for a FAI 1 Worlds.
- To reduce from 40 points to 30 points for a single event for FAI 1 Worlds.

# 380 – Proposal UK – Freeze WPRS for the 1st Year

# 38P – Proposal UK – Increase Launch Window Time

Presently the Launch Window for Paragliding is selected by allowing each pilot 30 seconds to launch. This is unrealistic for competitions and competitors and should be increased to 1 minute. Further, an additional 10 minutes should be allowed in the calculation to allow the last pilot a sporting chance to make the start gate.

#### 38Q — Proposal Spain — WG Rank Regional Events

To create a working group to find the best way to integrate regional type competitions in the WPRS ranking taking into consideration the singularity of these events (they are held during several weekends per year and a final ranking is obtained at the end of the season). Moreover, these events in general have a low number of pilots and their quality is usually low. In addition, the entry fee is usually cheap.

#### 38R— Proposal Spain — Junior sub-categorie:

Youth Category: -19 years old

Junior A: -23 years old

A pilot wishing to know if a task has been stopped or cancelled may request the "Task status". If the task is neither canceled nor stopped the response must not contain the words "Cancelled" or "Stopped", instead it must be "Task is running normally".

## 38X - Proposal Brazil - Event Dates

World's and Continental Championships are of utmost importance to CIVL, therefore any event organized by other Paragliding organizations, such as PWC, SRS, etc... must give 1 week for the pilots to travel from one competition to the other.

In case there is a coincidence, CIVL will not award points of the participants in the "other venue" and will not award WPRS points for NAC members of all events held in the same year.

The world Class 5 championships have always low numbers to be held by their own. In 2025 they will run with Class 1 worlds. On the other hand Class 1 worldwide has a lot of eligible pilots who can not compete because their spots are given to Class 5 European championships have less eligible pilots and lower attendance. This make them perfect to host a joined world class 5 championship.
