SCORING CATEGORIES

1. Overall
2. National (Swiss Championship)
3. National (German Championship)
4. Sport Class (min. 5 Competitors)

If less than 8 Competitors in Class 5 and Sport Class are present, they will be consolidated in the Overall Ranking with the corresponding factor.

If 5 or more Swiss Competitors in Class 5 are present, the title of Swiss Champion Class 5 will be given.

If 5 or more German Competitors in Class 5 are present, the title of German Champion Class 5 will be given.

If 5 or more Swiss Competitors in Class Sport are present, the title of Swiss Champion Class Sport will be given.

If 5 or more German Competitors in Class Sport are present, the title of German Champion Class Sport will be given.

In doubt, the "Sport Reglement", German Version as on the website of the Schweizerischer Hängegleiterverband is valid (www.shv-fsvl.ch).

SELECTION AND REQUIREMENTS

Maximum number of pilots: 70

Selection

Selection criteria for national pilots: All Swiss Pilots in order of the incoming payment
All German Pilots in order of the incoming payment

Selection criteria for non-national pilots: In order of the incoming payment. Swiss and German pilots have priority.

CIVL-ID

Airspace and other restrictions

According to the Swiss Law and the Swiss Airspace Map. Additionally, the DABS will be applied.

Landing site is at the southern edge of the Airport Buochs CTR, in a distance of 5km from the Airport. Security disposition with the Airport is defined.

In case of infringements, penalties will be applied. Concrete procedures will be announced at the General Safety Briefing.

LAUNCH SYSTEM

LOCAL REGULATIONS

There will be 2 - 4 lanes available per launch site. There is no special order and the order will be made on a bilateral basis between the pilots and the launch marshal. The pilots must line up fully ready to take-off and the launch marshal will do the last safety check prior to take-off.

Push system

According to Section 7a 3.3.6.

Relaunch

No relaunch unless mentioned at the Task Briefing.

In case of a re-flight the pilot must have not taken a start gate. The flight should be logged and stored for verification purposes. Individual transport should be used to the take-off area. The re-flight must be reported to the MD or launch marshal prior to the second take-off.

SAFETY ISSUES

Pilot reporting of safety

According to Section 7A-8.

Sign out/Landing forms

Safe Landing report through SMS and Whatsapp app is mandatory. In the interest of safety, pilot will sign out only after returning tracker at headquarters, personally or through an assistant, after the task, even if the task has been stopped. Penalty points may be applied for failure to follow this rule.

Medical services

A special urgency procedure will be defined with the local professional rescue service. The local hospital is in 15 minutes reachable from the official goal.

SCORING

GPS flight verification.

For scoring will be used the latest CIVL GAP formula in combination with the FS scoring program. GPSDump will be used for track download and waypoint upload.

See <http://www.gpsdump.no/> for a list of GPS units that is working with GPSDump.

If instrument is connected with non-standard (USB mini or USB-C) cable pilots are responsible to provide their own data cable.

The primary source of scoring is Live Tracking.

To be considered valid, back-up GPS track logs must comply with the current requirements in Section 7A-4. Any other source can be used as back-up, only if agreed by the Meet Director.

The GPS map datum is WGS 84 and the coordinate format to be used is UTM.

Scoring formula

The Actual GAP: GAP2021.

- Time points if not in Goal: 80%
- Jump the gun: Yes
- Max jump the gun: 300s
- Jump the gun: 2 points per second
- Score back time: 15min
- Scoring altitude: GPS

Scoring program*: FScomp as the official CIVL scoring program if no other is provided by the FAI.

GAP Parameters Open Class

- Nominal launch: 96%
- Nominal distance: 40 km
- Minimum distance: 7 km
- Nominal goal: 30%
- Nominal time: 1:00

If by demand a Sport Class will be held with different task setting, there will be separate parameters for the sport class.
